PERAMBULATION IN 1906.

- Starting at a Cross cut on the edge of Ludshott Common a few feet E. of the existing wrong road into the Manor, and 104 feet S.W. from the S. bank of the high road from Grayshott to Headley.
- Thence along the bank (now rather hidden in heather) some 400 paces or thereabout to a Cross W. by S. of Grayshott Hall.
- Thence, as in the Ordnance Survey, to the S. of Grayshott Hall, keeping some 2 rods from the old bank, to the end of a deep hollow.
- 4. Thence, as in the Ordnance Survey, to the S.W. point of the acre enclosure (where a Cross is cut, and a B on an oak tree) near the house belonging to the Executors of the late Mr. Woodthorpe.
 - 5. Thence, round by the curved bank to the road.
- 6. Thence, down the W. side of the road to Wagner's Pond head.
- 7. Thence, by the stream to the ram, and afterwards where the stream runs, i.e., up the lowest land.
 - 8. Thence through the penstocks.
- Thence in the ditch on the N. side of the road, below Mrs. Vertue's property, up to the further end of 1204 in the Ordnance Survey, 1897.
- Thence up the middle of the road to the hedge on the E. of Miss l'Anson's land.
- 11. Thence to a point in the S. hedge of the road, 20 paces up where bank stops.

- 12. Thence up the barbed wire fence passing through the W. gate post, to a point in the W. hedge of the land in the occupation of Mr. Moorey.
- 13. Thence to the E. hedge, passing about 1 rod from the front of the house; and on in the same direction through the cultivated plot.
 - 14. Thence again up the centre of the road.
- 15. Thence cutting off a corner of the small garden belonging to Mr. Mowatt, and out into the road about 2 chains up.
- 16. Thence up the S. hedge of the road to Wagner's Wells Bottom head, at the corner of the hedge by the apple tree. young with planted on wast position of add one

17. Thence nearly N. across the mouths of the two roads to the bend of the bank, the District Council boundary stone being some 20 feet too far to the W.

- 18. Thence in a straight line to where the Boundary Road meets the Headley Road (the whole of the Boundary Road being in the Parish of Grayshott).
- 19. Thence crossing this road to a point 3 feet W. of a bank which meets the N. side of the road.
- 20. Thence down the W. of this bank and 3 feet from it to the head of Whitmore Bottom, a distance of some 72 chains.
- 21. Thence down the S. of what was a bank, and is now the edge of a new occupation road, and further on taking the S. hedge where there are two parallel hedges on banks.
 - 22. Thence down the centre of the bottom.
- 23. Thence through the pond, and over the hedge, and down the lowland to a point in the line with the central hedge about \(\frac{3}{4} \) chain before the hedge is reached.
- 24. Thence down the lowland, over the cross hedge, and to where the pond was on the other side of the further cross hedge.
- 25. Thence over the hedge, round the N. side of the old pond, which is now marshy ground, and down the lowest land of the meadow to a point in the S. bank a chain from the W. bank.
- 26. Thence through the S. hedge cutting off a small piece of Mr. Leuchar's meadow. No. 1118 in Ordnance Survey.
- 27. Thence over the hedge and along the S. side of the hedge.
- 28. Thence across the hedge of the next field where the stream crosses it, and down the centre of the bottom; when flowing water is reached, this is followed and crosses the road from the N.E. to the S.W. side.

- 29. Thence along the centre of the stream except in three places where the stream has been straightened.
- 30. To a point on the stream 8½ chains from the S. end of Barford Pond, where the stream is crossed by the footpath from Hatch Farm to Llanover.
- Thence W. along a disused footpath to the Whitmoor Road.
- Thence S. along this road to the first public footpath (which is partly overgrown).
- 33. Thence W. along this footpath to its junction with Hammer Lane at the S.W. corner of Llanover.
- 34. Thence crossing the Hammer Lane diagonally to a point on the W. bank 1½ chains to the S. of that point in the same W. edge where the S. bank of Llanover would meet it if produced.
- 35. Thence in a straight line to a point on the N. side of the Headley and Grayshott Road opposite Cross as given in No. 1. passing the following points.
 - 35A. Diagonally through the Firs to about the centre of their N. side at 4 chains from Hammer Lane.
 - 35B. To the S. corner of the E. block of Hammer Firs; this point being on the public foot-way 8 chains from Hammer Lane.
 - 35c. Through the hollow 91 chains W. of the tank.
 - 35D. To a point on cleared ground 3½ chains due E. of the E. edge of the Quarry, this E. edge being due N. of the point given in No. 35.
 - 35E. From point 35D to point in No. 35 is 21 chains a little W. of S.
- 36. Thence crossing the Grayshott and Headley Road at a right angle along the existing wrong road into the Manor to the Cross on Ludshott Common in No. 1.
